1. Information We Collect

- **For Legal Compliance:** We may disclose your information if required to do so by law or to protect our legal rights.

Do Not Share Statement: We do not sell or rent your personal information to third parties for their marketing purposes. Any sharing of information is strictly limited to the purposes described above.

We take reasonable precautions to protect your personal information, but no method of transmission over the Internet or via SMS is 100% secure. While we strive to use commercially acceptable means to protect your data, we cannot guarantee absolute security.
